The University of Pisa, one of the oldest in the world, is committed to promoting quality in all areas of research and teaching. It has been successful in maintaining its resources and infrastructures to meet the new challenges, as well as its attractiveness for international students and researchers. In the University of Pisa, the Department of Economics and Management is one of the biggest departments, with lively research activities in management, applied mathematics, economics, and statistics. It serves about 6000 students, both at undergraduate and postgraduate level, coming from Italy, as well as from other countries of the world.

The Department of Economics and Management offers moreover a MSc in Economics, which is a standard two-year master program jointly organized with the Sant'Anna School of Advanced Studies of Pisa, and a one-year Master programme in Risk Management, as well as an International Semester with courses completely held in English. Given this international perspective, the department has established an International Relations Office that coordinates the various international programmes, promotes the mobility exchange of professors and researchers, organizes student exchanges through European Erasmus+ programme and relationship with No-EU institutions.

Every year the International Relations Office organises a welcome week for about 200 foreign students and supports them in Pisa with a Buddy Service orientation programme.

WHY MBE IN PISA?

The **MBE - Bachelor of Science in Management for Business and Economics** is a three years undergraduate program at the University of Pisa, completely held in English, with the primary mission to help young people to succeed in the business and economics fields. It is thought to be a one-way journey in the world of the international management for business and economics.

The aim of the MBE program is to provide professional knowledge of business management with an international overarching perspective, acquiring leadership skills and team building capabilities through the analysis of business cases and team work projects.

The lectures are held by an international faculty and the main topics and subjects include: marketing strategy, accounting and finance, auditing and management control, HR and organization. The course also provides key knowledge and tools of economics, business and commercial law, statistics and mathematics, as well as quantitative methods for business and economics. The study of a second language (French, Spanish, German and Business English) completes the programme.

Studying at MBE represents an opportunity to seek for different Job positions such as Junior Manager in any kind of firms in the fields: marketing, HR, auditing, management control, sales, international management.

REQUIREMENT FOR ADMISSION

The course has a limited number of students (90), the selection is based on the score obtained in one of the following tests: SAT, GMAT, TOLC-E. The test must be done before completing the application procedure and the related score must be included in the application. For the final score of the selection also Cambridge, IELTS, TOEFL certificate are considered.
